When a BCT LLC Distributor sponsors (The word 'sponsor' is understood to mean: A person or business brought into successful and contractual business agreement with BCT LLC) a person or company that becomes a BCT State Rep for his or her own state, or a different state, the BCT LLC Distributor will receive a twenty five dollar bonus/commission for every
6. BCT-PER and/or BCT-PRO complete System that the State BCT LLC Rep sells, provided that the sponsoring Distributor sells one complete BCT-PRO or BCT-PER System for the month that the sponsored BCT LLC's Rep's commissions/bonuses are payable on. Commissions/bonuses are paid quarterly within ten business days of the end of the quarter.
7. BCT LLC reserves the right to change and upgrade its products and marketing plan to include, but not limited to, parts, packaging shipping, brochures, pamphlets, web site pricing, structure, sales plan and any process BCT LLC deems beneficial by redefinition to the pricing and cost in regards to the creation of efficient and effective product and management. Distributors may not sell any product that BCT LLC deems to be in direct conflict of interest with BCT LLC products. Any Distributor found to be in conflict of interest and or competition with BCT LLC is subject to Distributorship termination. If Distributorship is terminated for any reason, Distributor will not be allowed to sell Bio-Cleanse products and will forfeit all past, present, and future customer base to BCT LLC. The agreements between BCT LLC and the Distributor, supersedes and takes precedence over any other agreement or contract the Distributor may enter or may have entered into with any other person, Company, or entity, in regards to loyalty, on or after the date on this agreement.
8. The undersigned agrees that as a Distributor, they must conduct themselves in an ethical, courteous, and professional manner. If a Distributor is unethical, such as, but not limited to, undercutting others, giving false information and/or conducting any business in any way, shape, or form that would be deemed by BCT LLC to be in direct conflict with proper, decent business ethics, then Distributor-ship may be terminated. If Distributorship is terminated for any reason, including the resignation of undersigned BCT Distributor, the undersigned may not sell any like product or produce any like product for resale for five years after last sales of a BCT LLC product as recorded by BCT. BCT LLC does not recognize any form of agreement between any party and/or parties other than original BCT LLC contracts. BCT LLC recognizes and accepts responsibility for BCT LLC warranties on BCT LLC products only.
9. When the undersigned BCT Distributor obtains a website, he or she must, within ten days, link it to biocleanse.info. and inform their Practitioners, of Practitioner map available on biocleanse.info for their advertising benefit.
10. A BCT-REP/Distributor may do home shows, events, rallies, expos, fairs, swap meets, and other attractions and events in state other than his/her own, as long as the BCT-REP/Distributor has obtained written permission from the BCT-REP/ Distributor of the state to be visited. One BCT-REP/Distributor, so as not to create conflict in the same show/event, may have a space at shows/events. However, two or more BCT-REPS/Distributors may work together in a joint effort at the same booth and the same show/event should this situation occur. The option is up to the BCT-REP/Distributor who will need to work out details between themselves. If BCT LLC deems, for any reason, any unethical action or problematic operations have occurred by a BCT-REP/Distributor, BCT LLC may override, terminate, or make void any operations or plans the BCT-REP/Distributor has made or may be making, paid for or not. BCT LLC may cancel the plans made by its BCT-REPS/Distributors with no legal ramifications or financial obligation or recourse to BCT LLC by BCT-REPS/Distributors or any entity representing BCT LLC REPS/Distributors, and they may not pursue any recourse, financial or otherwise against BCT LLC.
